He woke up after the injection and I could see that he was in pain. I then took him to the operating room and they performed surgery on his head. He was unconscious during the surgery. After the surgery, he was still in pain and I gave him more morphine. He eventually woke up and I could see that he was in better condition. He was able to move his arms and legs again. I then took him back to the hospital and he was admitted to the intensive care unit. He stayed in the hospital for several days and then was released. He has since recovered fully.
